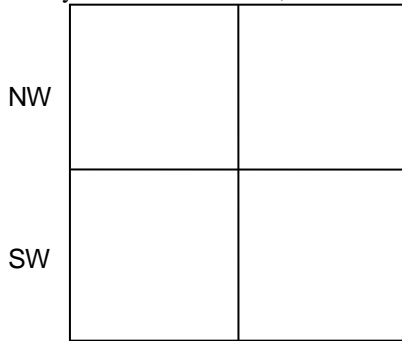

### General Terms and Conditions:

- Projects applied for must be within the TMCD;
- Failure of a landowner to meet Landowner Responsibilities may negate him / her from other TMCD programs;
- Will plow up to 2-inch pipe size; and
- No rental charge for use of the pipeline plow.

### Landowner Responsibility:

- Landowner to supply hose and tractor (min. 85hp and max. 125hp);
- Agree to care for the pipeline plow in a reasonable and prudent manner promptly reporting any damage sustained or repairs needed and be responsible for missing and or damaged parts outside normal wear and tear; and
- Grant the TMCD the right to use any information related to the pipeline plow for promotional purposes.

### Conservation District Responsibility:

- TMCD staff will deliver plow to and from landowners and accompany during use;
- Provide technical and on-site assistance; and
- Retain the option to use photos taken of the project for public relations purposes.
