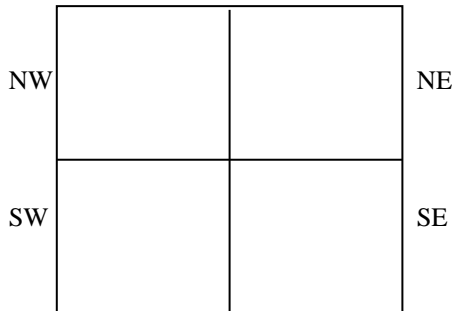

The Turtle Mountain Conservation District shall:

- 1) Notify landowners regarding the approval / disapproval of applications.
- 2) Provide salinity forage seed for planting.
- 3) Reserve the right to reasonable access to inspect the condition of the forage stands.
- 4) Retain the option to erect signage promoting the Salinity Seed Program.

The Landowner Shall:

- 1) Submit completed form to the TMCD office.
- 2) Sow seed on the land specified in the application in the 2019 growing season or report the circumstances to the TMCD.
- 3) Not sell, trade or exchange seed received under the Program.
- 4) Receive the consent of the TMCD prior to working up a planting in the establishment year.
- 5) Sow the seed within the TMCD
- 6) Provide access for inspection by the district.
- 7) Consent to signage indicating the landowner's participation in the program.
- 8) Failure of the landowner to meet the Landowner Responsibilities may negate him/her from other TMCD programs.
- 9) The registered landowner or renter of the land must fill out the application form.

It is understood that this agreement shall indemnify and save harmless the Turtle Mountain Conservation District #4, their agents, engineers, servants and/or employees from any liability which may result from the execution of the project.

I hereby declare that I have read the conditions of the Salinity Seed Assistance Program and that I agree to abide by the terms of the policy; and that I agree to co-operate to the fullest extent with the Turtle Mountain Conservation District #4 in completing and maintaining the project as outlined above.
