- Projects applied for must be within the SRWD (priority given to landowners in the Chain Lakes Sub-District); and
- Failure of a landowner to meet Landowner Responsibilities may negate him/her from other SRWD programs.

### Landowner Responsibility:

- Pay rental fee of \$50 for the 1<sup>st</sup> day and \$100 for each additional day (includes panels);
- If panels only pay rental fee of \$25;
- Agree to care for the system in a reasonable and prudent manner promptly reporting any damage sustained or repairs needed and be responsible for missing and or damaged parts outside normal wear and tear;
- Control livestock around the system; and
- Grant the SRWD the right to use any information related to the cattle handling system and panels for promotional purposes.

### Watershed District Responsibility:

- Pick up and return system from the SRWD warehouse;
- Provide landowners with operating instructions and assist with trouble shooting when required; and
- Retain the option to use photos taken of the project for public relations purposes.
