- Return the Tree Planter and/or Mulch Applicator in clean condition; and
- Grant the TMCD the right to use any information related to the Tree Planter use for promotional purposes.

### Conservation District Responsibility:

- Provide landowners with operating instructions and assist with trouble-shooting when required, and
- Retain the option to use photos taken of the project for public relations purposes.
