- Agree to care for the Tree Planter and/or Mulch Applicator in a reasonable and prudent manner promptly reporting any damage sustained or repairs needed and be responsible for missing and or damaged parts outside normal wear and tear;
- Return the Tree Planter and/or Mulch Applicator in clean condition; and
- Grant the SRWD the right to use any information related to the Tree Planter use for promotional purposes.

Watershed District Responsibility:

- Provide landowners with operating instructions and assist with trouble-shooting when required, and
- Retain the option to use photos taken of the project for public relations purposes.
